**RE: SUBMISSION OF MEMORANDA ON THE QUALITY HEALTHCARE AND
PATIENT SAFETY BILL (NATIONAL ASSEMBLY BILLS NO. 41 OF 2025)**

The Quality Healthcare and Patient Safety Bill (National Assembly Bills No. 41 of 2025) was read a First Time in the Senate on Wednesday, 15th July, 2026 and thereafter stood committed to the Standing Committee on Health for consideration.

The Committee is required, under standing order 145(5) of the Senate Standing Orders, to facilitate public participation on the Bill and to take into account the views and recommendations of the public when the Committee makes its report to the Senate.

The Bill seeks to give effect to Article 43(1)(a) of the Constitution by establishing a comprehensive legal and institutional framework for the promotion, regulation and continuous improvement of the quality of healthcare in Kenya. It sets out patient rights and corresponding facility obligations, establishes the Quality Healthcare and Patient Safety Authority to register, license, accredit and inspect health facilities, creates a specialized Health Care Tribunal to resolve health-sector disputes and prescribes offences and penalties for non-compliance with the provisions of the Act.

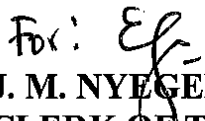
The purpose of this letter is to request you to submit any representations that you may have on the Bill by way of written memoranda.
